A. Election Inspector and Receiving Board Assignments

Recommendation: Approve the election inspector assignments for the November 7, 2023 General Election and allow the Election Coordinator to re-assign and/or pull from the alternate list of certified election inspectors as needed. Clerk Muray explained the policy regarding individuals working as Election Inspectors who are

related to candidates. Immediate family members of any candidate are not permitted to work on an Election when the candidate's name appears on the ballot.

B. Public Accuracy Testing

Recommendation: Establish October 18, 2023 at 8:30 a.m. on the 2nd floor Lobby as the date, time and place for public accuracy testing of two tabulators.
